CAMERON PEAK FIRE RECOVERY OPERATIONS

DEBRIS

Debris Operations for this week include cutting crews continuing along CR 44H in the gated winter closure section working towards Crystal Park and Crystal Mountain. Another cutting crew is on the Lower Buckhorn in Springtown Gulch and will be heading to Big Bear, Moondance Way and Hawk Valley Road next week. Lower Buckhorn chipping will be in Buckskin Heights, Redstone and Buffam Canyon Lane working towards Stringtown Gulch.

The contractor will not be closing any roads, but landowners should expect delays in the area.

LARIMER COUNTY CONSERVATION CORPS

The Conservation Corps crews have this week off. They will return next week with two crews and will be working in Crystal Park and Crystal Mountain.

The LC Conservation Corps has a crew dedicated to erosion control work for the next several weeks.

SANDBAGS & DUMPSTERS

Sandbags are available at multiple locations throughout the fire area. Dumpsters are also available for FIRE-RELATED debris through July 31st.

EMERGENCY WATERSHED PROTECTION PROJECTS

Larimer County has gathered a list of the specific addresses that are in each project area where structure protection is needed due to debris flow threats. Site visits continue and individual community members will start to be contacted to determine permissions for structure protection construction in each area.

CPRW / Greeley Projects: Aerial mulch polygon inspections have begun to scope areas for aerial mulch application. Contractor will begin treatment most likely within the next two weeks.



WEATHER UPDATE FROM NATIONAL WEATHER SERVICE



Only isolated high based showers and storms will be possible this afternoon with light rain and no flash flood threat. Showers and storms will become more numerous Tuesday afternoon and early evening, but only minor impacts would be possible as rainfall amounts should still be light. Wednesday would see the main threat for locally heavy rain on the Cameron Peak Fire burn area. Drier conditions should then redevelop for the upcoming weekend.
