LARIMER OFFICE OF EMERGENCY MANAGEMENT (LCOEM) SAFETY MESSAGE

It has been reported to LCOEM that our on-site crews have received threats from community members while working in our mountain communities. Some people have yelled obscenities, some have approached our crews and yelled at them to leave and one person even entered a county vehicle, removed tools and threw them out of the vehicle into the woods.

LCOEM understands that these incidents are not the voice of the majority and that many are grateful for the efforts that are occurring in the fire area. The incidents did, however, cause concern last week for the safety of our volunteers and personnel. If, at any time, our crews do not feel safe, they have been instructed to leave the area. Depending upon the incident, the crews may or may not return. Everyone we are working with expressed a deep desire to help in the fire area and to keep working where projects are needed to help the area recover. We have some great volunteers and young people donating their time to help Larimer County so we hope that they will be able to do so without threats of violence or angry outbursts in the future.

LCOEM asks that all community members be patient as our crews work. We know there may be delays because of limited road access and we understand that disaster recovery is incredibly stressful. We also ask that if there are concerns, that you do not take it out on the field crews and instead, contact Lori Hodges, Director of Emergency Management at hodgeslr@co.larimer.co.us.

DEBRIS

Debris Operations for this week include three cutting crews in the following areas: CR 44h heading down towards Crystal Mountain, Monument Gulch, Redstone Canyon, Stringtown Gulch and the Lower Buckhorm area. We will also have a chipping crew in Buckskin Heights. Crews will be mostly working in the designated right of way in Redstone Canyon since we have not received Right of Entry forms from the majority of community members in that area. LCOEM also conducted inspections in the Retreat and Storm Mountain last Friday so a cutting crew may return to remove a few missed trees in that area.

The contractor will not be closing any roads, but landowners should expect delays in the area.

If you have yet to sign the Right of Entry form allowing us to remove hazard trees along roadways and stream systems on private property, please do so as soon as possible by following the link below.
